2007–2010 Legislation Scored by the Humane Society Legislative Fund and Maryland Votes for Animals

SB 696 & HB 673 – Limiting Continuous and Inhumane Chaining of Dogs (2007): Prohibits tethering dogs between midnight and 6am or by use of a restraint that unreasonably limits the movement of the dog. **Passed Senate; Amended Version Signed into Law** • Sponsored by Senator Norman Stone and Delegate Susan McComas

SB 532 & HB 760 – Protecting Diamondback Terrapins (2007): Prohibits taking or possessing diamondback terrapins for commercial purposes. **Signed into Law** • Sponsored by Senator Roy Dyson and Delegate Virginia Clagett

SB 44 & HB 719 – Animal Fighting (2008): Increases penalties for people who knowingly attend animal fights. **Signed into Law** • Sponsored by Senator Norman Stone and Delegate James Malone

SB 615 & HB 1257 – Protecting Pets in Cases of Domestic Abuse (2008): Allows the inclusion of protections for pets and service animals in protective orders. **Passed the Senate** • Sponsored by Senator Jamie Raskin and Delegate Susan McComas

HB 1481 – Promoting Humane Euthanasia (2008): Allows the State Board of Veterinary Medical Examiners to issue licenses to allow humane societies and county animal shelters to administer drugs needed to sedate and euthanize animals. **Signed into Law** • Sponsored by Delegate Jon Cardin

HB 134 – Protecting Dogs in Pickups (2008): Prohibits transporting pets in trucks unless they are confined. **Passed the House** • Sponsored by Delegate Kevin Kelly

SB 110 & HB 546 – Protecting Pets in Pickups (2009): Prohibits a person from transporting pets in or on a truck or trailer on a highway unless the vehicle is enclosed or the pet is confined. **Failed in the Senate** • Sponsored by Senator Norman Stone and Delegate Kevin Kelly

SB 736 & HB 901 – Protecting Pets in Cases of Domestic Abuse (2009): Allows for the inclusion of protections for pets and service animals in protective orders. **Passed the Senate** • Sponsored by Senator Jamie Raskin and Delegate Susan McComas

SB 342 & HB 208 – Requiring Labeling of Products Made of Fur (2009): Requires all garments containing fur to be labeled with the species of animal and country of origin. **Passed the Senate** • Sponsored by Senator Catherine Pugh and Delegate Tom Hucker

HB 149 – Pet Trusts (2009): Allows for the creation of pet trusts. **Signed into Law** • Sponsored by Delegate Wade Kach

HB 831 – Banning Cruel Traps in Montgomery County (2009): Bans body-crushing traps in Montgomery County and removes the exemption allowing leghold traps to be used on farmland. **Passed the House** • Sponsored by Delegate Brian Feldman

HB 858 – Banning Cruel Traps in Montgomery County (2010): Bans body-crushing traps in Montgomery County and removes the exemption allowing leghold traps to be used on farmland. **Passed the House** • Sponsored by Delegate Tom Hucker and Senator Mike Lenett

SB 21 & HB 265 – Increasing Penalties for Animal Cruelty (2010): Increases the penalties for misdemeanor animal cruelty and allows courts to prohibit people convicted of animal cruelty from owning animals in the future. **Passed the Senate** • Sponsored by Senator James Robey and Delegate Jeff Waldstreicher

SB 1057 – Limiting the Continuous and Inhumane Chaining of Dogs (2010): Prohibits tethering a dog between the hours of 10pm and 6am and during a snow emergency. **Failed in the Senate** • Sponsored by Senator Norman Stone

THE SCORECARD

The **Humane Society Legislative Fund** and **Maryland Votes for Animals** publish this Humane Scorecard to assess the support of Maryland state legislators on a broad range of animal protection issues. The Scorecard provides an easy way for you to judge how your state senators and delegates have acted on animal protection measures during the 2007–2010 legislative sessions and helps chart the progress of our public policy work on behalf of animals.

HOW SCORES ARE CALCULATED

Many animal protection issues never receive floor votes in Annapolis. Some fail in committee and some languish until the end of session, never receiving a vote. To accurately measure legislators' support for animal protection over the past four years, we scored all House and Senate floor votes and several key committee votes, and indicated sponsorship or co-sponsorship of measures. Scores are given as percentages of the total number of items counted, which varies for each legislator. Details can be found at hslf.org.

We hope you'll use the Scorecard as a tool to ensure your legislators are representing your interests. Let them know you're watching and you appreciate their support for pro-animal legislation.
