## Measures of Progress for Animals

Dear Friends,

The first year of the 111th Congress saw a number of advances for animal protection policies, prepping the way for final action this year on many important bills and bringing new issues into the political discourse.

Wildlife protection made great strides in the House of Representatives, which passed 11 measures to help native and exotic wild animals, including a prohibition on the pet trade in primates and a bill to overhaul management of wild horses and burros on public lands. Other House-approved bills would bring protections to ocean dwellers by ending shark finning, providing grants for marine mammal rescue, and promoting the recovery of Pacific sea otters. The House also took a stand in favor of wildlife preservation, passing measures to help imperiled cranes, great cats and rare canids, and marine turtles; to strengthen penalties for intentional killing of federally protected birds; and to create a wildlife stamp to fund multinational species conservation. The Senate unanimously approved a resolution (passed by the House in the last Congress) calling on the Canadian government to end its commercial seal hunt.

Key issues were also addressed in enacted funding bills for federal agencies. Among the achievements were provisions to block expenditures on horse slaughter and end the slaughter of downed cattle, promote and fund nonanimal research methods, study the use of service dogs for rehabilitating veterans, and increase appropriations to implement international agreements for wildlife conservation and improve enforcement of key domestic animal welfare laws.

Despite all these advances, Congress took a few steps backwards on other issues, blocking the collection of data on greenhouse gas emissions from the largest factory farms and overturning a long-standing federal ban on carrying loaded firearms in national parks. And a number of key bills still need to cross the finish line; though many have Senate champions and some have won committee approval in that chamber, none has received a floor vote there.

In 2010, HSLF will continue to seek Senate passage of those measures. We'll also pursue enactment of legislation to ban trade in nine species of large constrictor snakes, as well as bills on horse slaughter, fur labeling, antibiotic misuse on factory farms, invasive research on chimpanzees, puppy mills, the trade in stolen and otherwise fraudulently obtained pets for research, a tax credit for spaying and neutering pets, and the remaining loophole that allows slaughter of downed calves, among a host of other concerns affecting pets, farm animals, and wildlife.

I invite you to use the *Humane Scorecard* as a guide to congressional action on animal issues in 2009—and to see whether your own representative and senators made the grade. Please share this scorecard widely, and join us as we redouble our efforts in 2010 for an animal protection agenda in Congress.

## About the Scorecard

THE HUMANE SOCIETY LEGISLATIVE FUND publishes an annual *Humane Scorecard* to assess the support of federal legislators on a broad range of animal protection issues. This *Scorecard* provides an easy way for you to assess how your U.S. senators and representatives have acted on these issues during the first year of the 111th Congress (which runs from January 2009 through December 2010), and it helps chart the progress of our public policy work on behalf of animals.

## How Scores Are Calculated

Many animal protection issues never receive a recorded vote in Congress. Some are enacted by voice vote, and some languish. To accurately measure legislators' support for animal protection over the past year, we count not just recorded votes but other meaningful ways they can help issues advance in Congress, such as cosponsorships of key bills and cosigning funding letters seeking increased enforcement of animal welfare laws. Scores are given as percentages of the total number of items counted (six for the Senate and 13 for the House). Prime sponsors of pro-animal legislation also receive "extra credit" equal to one vote or cosponsorship, unless they already had a score of 100—in that case, their scores appear in bold with a plus sign.

HSLF acknowledges the limitations of judging legislators based on a few votes, cosponsorships, and joint letters. In some cases, legislators must miss votes for unavoidable reasons, such as a death in the family, serious illness, or birth of a child. Please also consider such unrecorded matters as performance on committees and constituent service.

## What Else Can You Do?

We hope you'll use the *Scorecard* as a tool to ensure your legislators are representing your interests. Let them know you're watching and you appreciate their support for pro-animal legislation. Or, if they haven't done enough, let them know you'd like to see them do more. Also, you can write a letter to the editor of your local newspaper to call attention to these issues. ### Leaders

A ✓ indicates that the member led as a prime sponsor of pro-animal legislation (including items not scored on this chart).

### Horse Slaughter

A ✓ indicates that the member cosponsored S. 727 to prohibit the knowing and intentional transport, including export, of horses to be slaughtered for human consumption. More than 90,000 American horses were purchased in 2009 by “killer buyers,” who often outbid legitimate adopters and rescue groups at auction. The horses are shipped long distances to cruel deaths in Mexican and Canadian slaughterhouses that cater to the palates of European diners.

**Status:** Pending in Judiciary Committee; 28 cosponsors at press time

### Fur Labeling

A ✓ indicates that the member cosponsored S. 1076 to require species labeling on any fur product regardless of value. This requirement will enable consumers to make informed choices and help combat the import of cat and dog fur. A loophole in federal law allows garments with fur val-



ued at \$150 or less to be sold in the U.S. without disclosure of the use of real fur or the species used.

**Status:** Pending in Commerce, Science, and Transportation Committee; 33 cosponsors

### Antibiotics Overuse

A ✓ indicates that the member cosponsored S. 619 to phase out the routine nontherapeutic use of antibiotics in farm animals. This practice serves as a crutch to support overcrowded, unsanitary factory farming conditions and undermines the effectiveness of antibiotics for treating sick people and animals.

**Sponsors:** Sens. Ted Kennedy, D-Mass.; Olympia Snowe, R-Maine

**Status:** Pending in Health, Education, Labor, and Pensions Committee; 18 cosponsors

### ESA Rule Repeal

A ✓ indicates that the member voted against Senate Amendment 599, introduced by Sen. Lisa Murkowski, R-Alaska, to strip language from H.R. 1105, the fiscal 2009 Omnibus Appropriations Act, that authorized the Obama Administration to expeditiously withdraw damaging Endangered Species Act rules issued in the final days of the Bush Administration (pro-animal vote: Nay).

**Status:** Failed Senate 42-52 in March; H.R. 1105 was signed into law in March as P.L. 111-8 with the ESA language intact; Obama Administration rescinded Bush ESA rules in May

### Guns in Parks

A ✓ indicates that the member voted against Senate Amendment 1067, introduced by Sen. Tom Coburn, R-Okla., to H.R. 627, a credit card reform bill, to remove the long-standing federal ban on carrying loaded firearms in national parks. This prohibition had served for decades as an invaluable tool for park rangers to prevent wildlife poaching (pro-animal vote: Nay).

**Status:** In May, S.A. 1067 passed Senate 67-29 and House voted 279-147 to concur; it was signed into law in May as part of P.L. 111-24



### Funding Letter

A ✓ indicates that the member cosigned a group letter in May to the Agriculture Appropriations Subcommittee, seeking funds for enforcement of the Humane Methods of Slaughter Act, Animal Welfare Act, and federal animal fighting law, as well as for programs to address the needs of animals in disasters and to ease a shortage of veterinarians in rural and inner-city areas and public health practice through student loan forgiveness. Subcommittee and committee leaders—Sens. Herb Kohl, D-Wis.; Sam Brownback, R-Kan.; Daniel Inouye, D-Hawaii; and Thad Cochran, R-Miss.—don't sign letters to themselves but received credit because they were very responsive to these requests, sought by 41 senators.

**Sponsors:** Sens. Carl Levin, D-Mich.; David Vitter, R-La.

**Status:** Nearly all of the funding sought was provided in P.L. 111-80

This requirement will enable consumers to make informed choices and help combat the import of cat and dog fur. A loophole in federal law allows garments with fur valued at \$150 or less to be sold in the U.S. without disclosure of the use of real fur or the species used.

**Sponsors:** Reps. Jim Moran, D-Va.; Mary Bono Mack, R-Calif.

**Status:** Pending in Energy and Commerce Committee; 161 cosponsors

### Antibiotics Overuse

A ✓ indicates that the member cosponsored H.R. 1549 to phase out the routine nontherapeutic use of antibiotics in farm animals. This practice serves as a crutch to support overcrowded, unsanitary factory farming conditions and undermines the effectiveness of antibiotics for treating sick people and animals.

**Sponsor:** Rep. Louise Slaughter, D-N.Y.

**Status:** Rules Committee hearing held in July; 106 cosponsors

### Chimpanzees in Research

A ✓ indicates that the member cosponsored H.R. 1326 to phase out the use of chimpanzees in invasive research, retire all federally owned chimpanzees

to sanctuary, and codify the NIH moratorium on breeding of these animals for invasive research. Approximately 1,000 chimpanzees are languishing in eight laboratories across the U.S., costing taxpayers millions of dollars each year to warehouse them. As chimpanzees have proven to be poor research models for human illness, most are not being used in active protocols; many have lived for decades behind bars.

**Status:** Pending in Energy and Commerce Committee; 141 cosponsors

### Primates as Pets

A ✓ indicates that the member voted for H.R. 80 to prohibit interstate and foreign commerce in nonhuman primates for the pet trade. Captive primates can inflict serious injuries and spread life-threatening diseases, and the average pet owner cannot provide for their basic social and physical needs in captivity. Purchased as infants, the animals are often confined to small cages when they become too dangerous to manage. (Senate companion bill, S. 462, introduced by Sens. Barbara Boxer, D-Calif., and David Vitter, R-La.)

**Sponsors:** Reps. Earl Blumenauer, D-Ore.; Mark Kirk, R-Ill.

**Status:** Passed House 323-95 in February; passed Senate Environment and Public Works Committee in July



### Cranes

A ✓ indicates that the member voted for H.R. 388 to fund conservation programs for imperiled crane populations in the U.S. and around the world. The bill would add cranes to the list of animals supported by the congressionally created Multinational Species Conservation Fund. (Senate companion bill, S. 197, introduced by Sens. Russ Feingold, D-Wis., and Mike Crapo, R-Idaho)

**Sponsor:** Rep. Tammy Baldwin, D-Wis.

**Status:** Passed House 288-116 in April; passed Senate Environment and Public Works Committee in July

## Great Cats/Rare Canids

A ✓ indicates that the member voted for H.R. 411 to fund the conservation of rare felids and canids, such as jaguars, leopards, cheetahs, and African wild dogs, in the animals' natural ranges. The bill adds these species to the Multinational Species Conservation Fund and directs the Interior Department to identify which projects should receive financial assistance. (Senate companion bill, S. 529, introduced by Sens. Joe Lieberman, I-Conn., and Sam Brownback, R-Kan.; passed Environment and Public Works Committee in July)

**Sponsor:** Rep. Jay Inslee, D-Wash.

**Status:** Passed House 290-118 in April

## Guns in Parks

A ✓ indicates that the member voted against section 512—introduced by Sen. Tom Coburn, R-Okla.—to H.R. 627, a credit card reform bill. Sec. 512 removed the long-standing federal ban on carrying loaded firearms in national parks. This prohibition had served for decades as an invaluable tool for park rangers to prevent wildlife poaching (pro-animal vote: Nay).

**Sponsor:** Rep. Carolyn McCarthy, D-N.Y., led the fight against sec. 512

**Status:** In May, Coburn amendment passed Senate 67-29 and House voted 279-147 to concur on sec. 512, which was signed into law in May as part of P.L. 111-24

## Wild Horses

A ✓ indicates that the member voted for H.R. 1018 to restore the prohibition on the commercial sale and slaughter of wild free-roaming horses and burros and to provide for more humane and effective management on the range. The bill would strengthen the adoption program for these animals, facilitate creation of sanctuaries, and implement birth control as a more cost-effective and humane means of herd reduction than the current system of roundups and warehousing in holding facilities. (Senate companion bill, S. 1579, introduced by Sen. Robert Byrd, D-W.Va.)

**Sponsors:** Reps. Nick Rahall, D-W.Va.; Raul Grijalva, D-Ariz.

**Status:** Passed House 239-185 in July

## Sea Otters

A ✓ indicates that the member voted for H.R. 556 to establish a recovery program for the Southern sea otter. According to the U.S. Geological Survey, the sea otter population along California's coast has experienced a severe decline, with otters dying from bacteria, viruses, and parasites found in urban sewage and from agricultural runoff that pollutes creeks and coastal waters. (Senate companion bill, S. 1748, introduced by Sen. Barbara Boxer, D-Calif.)

**Sponsor:** Rep. Sam Farr, D-Calif.

**Status:** Passed House 316-107 in July

## Marine Turtles

A ✓ indicates that the member voted for H.R. 509 to authorize an addi-



tional five years of grants for marine turtle conservation projects in foreign countries, expand eligibility to include projects in the U.S., and increase authorized funding levels. Several species of marine turtles are in jeopardy due to capture for fisheries, habitat destruction from coastal development, poaching, entanglement in marine debris, ship strikes, and ocean pollution.

**Sponsors:** Reps. Henry Brown, R-S.C.; Madeleine Bordallo, D-Guam

**Status:** Passed House 354-72 in July; passed Senate Environment and Public Works Committee in December

## Factory Farms/Climate Change

A ✓ indicates that the member voted against a motion by Rep. Mike Simpson, R-Idaho, to instruct conferees of H.R. 2996—the appropriations bill for the Department of Interior and the Environmental Protection Agency—to retain an amendment offered in committee by Rep. Tom Latham, R-Iowa, barring the EPA from collecting greenhouse gas emissions data from the largest confined animal feeding operations. (pro-animal vote: Nay)

**Status:** In October, Simpson's motion passed House 267-147; Latham amendment retained by conferees and signed into law as part of P.L. 111-88

## Funding Letter

A ✓ indicates that the member cosigned a group letter in April to the Agriculture Appropriations Subcommittee seeking funds for enforcement of the Humane Methods of Slaughter Act, Animal Welfare Act, and federal animal fighting law, as well as for programs to address the needs of animals in disasters and to ease a shortage of veterinarians in rural and inner city areas and public health practice through student loan forgiveness. Subcommittee and committee leaders—Reps. Rosa DeLauro, D-Conn.; Jack Kingston, R-Ga.; David Obey, D-Wis.; and Jerry Lewis, R-Calif.—don't sign letters to themselves but received credit because they were very responsive to these requests, sought by 135 representatives.
